This fee is \$615 for the Fall semester and \$600 for the Spring semester.  <sup>2</sup>Clemson Site Services/Activity Fee covers student access to healthcare, recreation, academic support and other student activities at Clemson University. This fee is \$550 per semester.  <sup>3</sup>Highpointe Academic Facilities Fee covers the costs for the academic support building at Highpointe of Clemson where meetings, tutoring, and social activities occur for all Bridge students. The \$290 Academic Facilities Fee is due in the Fall semester only.
