

## SELECTIVE SERVICE VERIFICATION

According to our records, your Selective Service registration or exemption status was not confirmed by the Selective Services system. As a result, you must provide written documentation as proof of your registration or exemption status. Read the statements below, select the category that best describes your situation and take the appropriate action immediately:

**Category A:**

*I am a male U.S. citizen or eligible non-citizen, born after December 31, 1959, who is 18 but not yet 26 years of age. You must register with Selective Service. Attach a copy of your registration card or a "Status Information Letter" from Selective Service verifying your registration status to this form and return to the Financial Aid Office. Selective Services Web site is [www.sss.gov](http://www.sss.gov).*

**Category B:**

*I am a male U.S. citizen or eligible non-citizen, 26 years or older, born after December 31, 1959, who has never registered with Selective Service. You must attach the "Status Information Letter" from the Selective Service and a written letter explaining the circumstances as to why you did not register to this form and return to the Financial Aid Office. For more information on verifying your registration status and for the Selective Services Status Request Form, visit the Selective Services Web site at [www.sss.gov](http://www.sss.gov).*

**Category C:**

If you do not fall into one of the following categories, you must submit the documentation described above.

I certify that I am not required to be registered with Selective Service because:

*I am a female. You did not answer male or female on the FAFSA. Provide a copy of a photo ID or birth certificate to confirm your gender.*

*I have not reached my 18<sup>th</sup> birthday. Provide a copy of a photo ID or birth certificate to confirm your date of birth, and a signed statement confirming that you will register for Selective Service once you reach the age of 18.*

*I was born before 1960. Provide a copy of a photo ID or birth certificate to confirm your date of birth.*

*I am a resident of the Federated States of Micronesia or the Marshall Islands, or permanent resident of the Trust Territory of the Pacific Islands (Palau). Provide a copy of a passport or birth certificate to confirm your residence.*

*I am in the Armed Services on active duty. Attach a copy of active duty military ID. (NOTE: Does not apply to members of the Reserves and National Guard who are not on active duty.)*

*I am a noncitizen/citizen who first entered the U.S. after I turned 26. Attach a copy of your I-94, I-551 or a copy of your entry visa and passport. This must document your first date of entry to the U.S. If your status dates do not prove that you first entered after you turned 26, you will need to request a Status Information Letter from Selective Service ([www.sss.gov](http://www.sss.gov)).*

*I am a noncitizen/citizen who entered the U.S. as lawful nonimmigrant status and remained in the U.S. under the terms of that visa until after age 26. Attach a copy of I-94, I-551 or a copy of your entry visa and passport. This must document your first date of entry to the U.S. If your status dates do not prove that you remained in a nonimmigrant status until after you turned 26, you will need to request a Status Information Letter from Selective Service ([www.sss.gov](http://www.sss.gov)).*

If you believe you are already registered, regardless of your age, you must contact the Selective Service and provide us a copy of your registration card or a "Status Information Letter" from Selective Service verifying your registration status. You can also print this letter from the Selective Service website – [www.sss.gov](http://www.sss.gov).

If you have any questions regarding your registration and/or exemption status, contact Selective Services at (888)655-1825. Since written documentation is required to resolve any discrepancy, you are responsible for contacting Selective Service directly.
