



2009-2010 LIFE SCHOLARSHIP CERTIFICATION & AFFIDAVIT

ELIGIBILITY CRITERIA

- Must be a legal resident of South Carolina
- Must be a United States citizen or a permanent resident
- Must be a graduate from a high school in South Carolina, or successfully completed a home school program as prescribed by law, or graduated from a preparatory high school outside South Carolina, while a dependent of a parent or guardian who is a legal resident of South Carolina and has custody of the dependent
- Admitted and classified as a degree-seeking student and enrolled full-time (12 or more eligible credit hours).
- Working toward your first undergraduate degree
- Will use the LIFE Scholarship for tuition and fees and other educational costs at Tri-County Technical College
- Have not defaulted and do not owe a refund or repayment on any Federal or State financial aid

IMPORTANT NOTE: The following courses **DO NOT** count toward LIFE Scholarship enrollment status:

LIFE scholarship pays up to the cost of tuition, plus \$150.00 each fall and spring semesters. LIFE scholarship funds are credited to the eligible student’s account and are used for tuition and other charges that may have been charged on the student’s account.

Your final high school transcript must be on file in our Admissions Office and a LIFE scholarship affidavit has to be read and signed by the student before LIFE eligibility can be established. Once eligibility has been established, the student must be enrolled in the appropriate courses for the LIFE scholarship to pay. Failure to be enrolled in appropriate courses at the time payment is due will result in the LIFE scholarship being removed from the student’s account.

TRANSFER STUDENT ONLY

A transcript from the previous college and a high school transcript must be on file with Admissions before LIFE scholarship can be determined for eligibility.

LIFE AFFIDAVIT

READ CAREFULLY BEFORE SIGNING

I certify I have never been an adjudicated delinquent, convicted, or pled guilty or *nolo contendere* to any felonies or any second or subsequent alcohol/drug related offenses under the laws of this or any other state or under the laws of the United States in order to be eligible for a LIFE Scholarship, except that a high school or college student otherwise qualified who has been adjudicated delinquent or has been convicted or pled guilty or *nolo contendere* to a second or subsequent alcohol or drug-related misdemeanor offense nevertheless shall be eligible or continue to be eligible for such scholarships after the expiration of one academic year from the date of the adjudication, conviction, or plea by submitting an affidavit each academic year to the institution. However, a high school or college student who has been adjudicated delinquent, convicted, or pled guilty or *nolo contendere* of a second alcohol/drug related misdemeanor offense is ineligible for the next academic year of enrollment at an eligible institution after the date of the adjudication, conviction or plea. If the adjudication, conviction, or plea occurs during the academic year after the student has already submitted a signed affidavit to the institution, the student will be eligible to receive the Scholarship the remainder of the academic year. However, the student will be ineligible for the Scholarship the following entire academic year of enrollment. If a student completes a pretrial intervention program and has his/her record expunged the conviction will not affect Scholarship eligibility.

I also have read and understand that obtaining funds through means of a willfully false statement or through failure to reveal material fact, condition or circumstances affecting eligibility, will be subject to applicable civil or criminal penalties including loss of LIFE Scholarship funds.
