If you and/or your spouse have never filed taxes, order your IRS Verification of Non-Filing Letter by completing IRS Form 4506-T (found at www.irs.gov) and returning it to the IRS by fax or mail. **Include student's TCTC ID on Line 5b "Customer File Number."** *DO NOT SEND FORM 4506-T to Tri-County.*
